### Directions:

#### From Red Deer:

- South on QE2 to Olds Turnoff (Hwy 27)
- West on 27 to Hwy 22
- South on 22 to Bergen Road
- West on Bergen Road about 9 km (past Bergen Store and over Bridge) to RR 53 (Fallen Timber Trail)
- South on RR 53 to Twp. Rd 312 Turn West (you will go through two large 90 degree curves in the road, the first road after the curves is the 312)
- West on 312 for 2 km (you will pass RR 54), and turn north into our drive

#### From Calgary:

- Go North on Hwy 22 (west of Calgary)
- Go 5.3 km north of the town of Cremona to the Burnt Timber Road
- West on Burnt Timber about 9.7 km to the Fallen Timber Trail (also known as RR 53)
- Go north on Fallen Timber 3.3 km, veer left (west) at Y, cross bridge, then immediately turn North on Fallen Timber Road / RR 53
- North on Fallen Timber Trail (RR 53) 3 km to Twp Rd. 312
- West on 312 for 2 km (you will pass RR 54) and turn north into our drive
